CONTEXT & PURPOSE

ULEARN-EDU, the WEBSITE, is owned and operated by ULEARN Knowledge and ULEARN-EDU Pvt. Ltd., a company duly incorporated under the provisions of the Companies Act, 1956.

ULEARN Knowledge and ULEARN-EDU Pvt. Ltd. ("ULEARN," "we," "our," or "us") is committed to respecting and protecting your privacy. This Privacy Policy applies to the ULEARN website, <http://www.ULearn-edu.in/> (hereinafter referred to as "ULearn-Edu"), and describes how we collect, protect, use, and share information gathered about you on our websites or mobile service. By using our Service, you agree to the terms of this Privacy Policy.

The Website is an Online Youth Mentoring Youth platform that helps students discover and pursue their passion by connecting to young achievers Below the age of 25 in those respective fields of Passion (hereinafter referred to as "Services", with the relevant pharmacies referred to as "You" or "Your" or "Yourself" or "Sellers" or "Users"). The arrangement between the Sellers and Buyers shall be governed in accordance with this Terms of Use. The Services would be made available to such natural persons who have agreed to become buyers on the Website after obtaining due registration, in accordance with the procedure as determined by ULEARN, from time to time ("Buyer"). The Services are offered to the Buyers through various modes which shall include issue of discount coupons and vouchers that can be redeemed for various goods/ services offered for sale by the Sellers. For the purpose of providing the Services and for other purposes identified in this Privacy Policy, ULEARN will be required to collect and host certain data and information of the Sellers/Users. ULEARN is committed to protecting the personal information of the Users and takes all reasonable precautions for maintaining confidentiality of the Seller's personal information.

This Privacy Policy has been designed and developed to help you understand the following:

The type of personal information (including sensitive personal data or information) that ULEARN collects from the Sellers.

The purpose of collection means and modes of usage of such personal information by ULEARN.

How and to whom ULEARN will disclose such information.

How ULEARN will protect personal information including sensitive personal data or information that is collected from the Buyers.

How Buyer's may access and/ or modify their personal information.

This Privacy Policy shall apply to the use of the Software by all Buyers / Sellers. Accordingly, a condition of each Seller's use of and access to the Software and to the other services provided by ULEARN to Buyers is their acceptance of this Privacy policy. Any Seller is required to read and understand the provisions set out herein prior to submitting any sensitive personal data or in-formation to ULEARN, failing which they are required to leave the Software immediately. This Privacy Policy is published in compliance of the (Indian) Information Technology Act, 2000 and the rules, regulations, guidelines, and clarifications framed thereunder, including the (Indian) Information Technology (Reasonable Security Practices and Procedures and Sensitive Personal Information) Rules, 2011.

TYPE OF INFORMATION COLLECTED

When you visit the Website, we may collect certain non-personal information such as your Internet Protocol ("IP") address, operating system, browser type, and Internet service provider. This type of information does not identify you personally.
